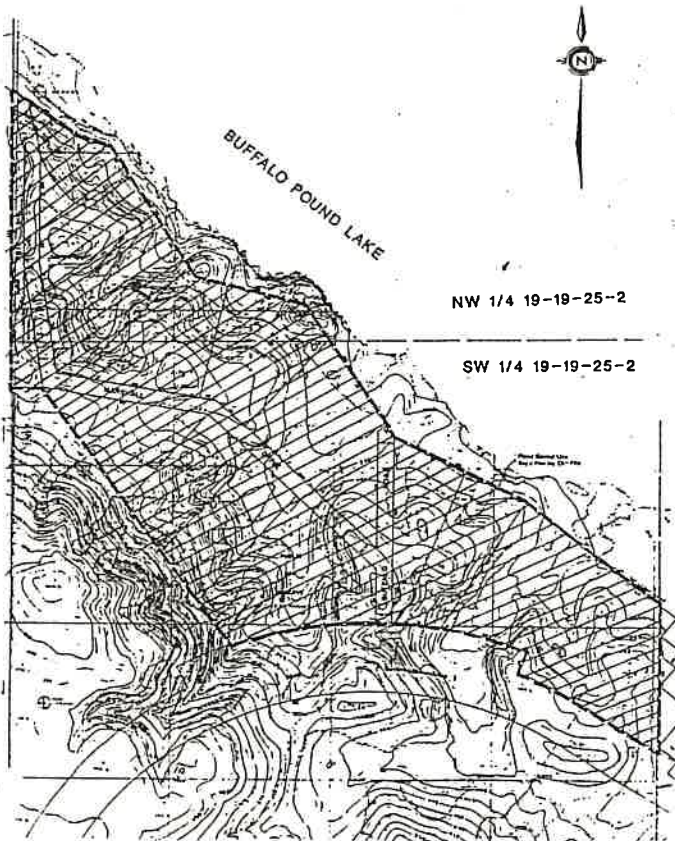
Authority

Map Change - Baker Holdings Ltd. Lands

To rezone certain lands in the W $\frac{1}{2}$  19-19-25-2 from Agriculture 2 to Urban- Country Residential, as shown below:

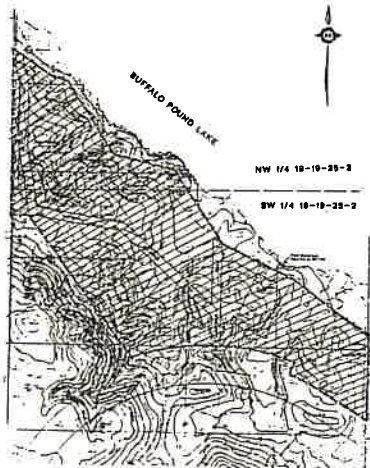
**PUBLIC NOTICE**

**Map Change - Baker Holdings Ltd. Lands**

To rezone certain lands in the W $\frac{1}{2}$  19-19-25-2 from Agriculture-2 to Urban-Country Residential as shown below:



 AREA TO BE REZONED FROM AGRICULTURE 2 TO URBAN - COUNTRY RESIDENTIAL
