- Money to repair roads further is not available. Dust control will be done this year, however no new gravel will be coming
- What we have learnt about the Water Board Hamlet of Parkview Water Users Inc is a joint entity with the Hamlet of Parkview Board of Directors, as well as the Parkview Water Users Board – there has been no one from the Board of Directors sitting on the Board, however this is changing
- Have paid out the Water Board more than the \$70,000 originally discussed, upwards of \$78,000 now
- Looking for material for the Water Users Inc, if anyone knows where documents can be located or who can be contacted the information would be appreciated
