Instructions to Bidders

Sealed tenders addressed to the Village of Marquis, and plainly marked on the envelope “**TENDER FOR PURCHASE OF EQUIPMENT**” will be received until **4:00 p.m. on June 19, 2024**, for the following equipment:

- John Deere Riding Mower, JDZ445, 25 HP, 54” Deck, Kawasaki Motor, Swisher Grass Trimmer.
- Three Point Hitch, 5-foot John Deere 506 Mower.

All bids are irrevocable for a period of 14 days from tender closing date. All tenders become the property of the Village of Marquis until such time as a tender is awarded or rejected.

Bids must be determined independently from any other bidder or potential bidder. If, in the opinion of the Village, there is any appearance that a bidder has consulted another bidder or potential bidder regarding:

- (a) prices;
- (b) methods, factors, or formulas to calculate prices;
- (c) the intention or decision to submit, or not submit, a bid; or
- (d) any other indication of collusion regarding bid prices;

The Village may in its discretion, take any action it considers appropriate, including rejecting any bid or disqualifying any bidder from bidding on this tender or another tender.

No multiple bids for a single item will be accepted.

No conditional bids will be accepted.

Highest or any tender not necessarily accepted.

Bidders who are either a councillor or an official with the Village of Marquis must identify on the front of the sealed bid that they are employed by the municipality.

The successful bidder must provide the Village of Marquis with the total amount owing prior to pickup. Payment can be made by e-transfer to admin@rmofmarquis.com, debit, cash or cheque within 14 days of notification of award of the tender.

The items are being sold “as is”. There are no representations or warranties expressed or implied, including without limitations as to fitness of the items for any particular purpose.

There will be no exceptions as to the conditions of this tender.
