## 2023 Financial and 2024 Budget

#### **Old Business:**

Lorass – the big bin is back in the hamlet for fall clean-up, for a month or so depending on how much it is being used. Please do not over fill it as Lorass needs to tarp it to drive on the highway.

### **Volunteer training:**

RM will advise when training will be available, currently no one is available to train. To operate the tractor or lawnmower you must be certified. Looking into separate training just for operating the lawnmower. The board is looking into outside options for training volunteers.

### **Quonset roof:**

RM suggested Quonset roof is patchable. Will not be an insurance claim as deductible to high and premium will go up. Still looking for a contractor who will come out to the Hamlet. Any suggestions from contractors appreciated.

#### **Culverts:**

We will be mapping where new ones are.

#### Guard rails:

Hamlet residents will be speaking to the RM about reflectors and posts on the hill.

#### **New business:**

**Year in review:** A resident was successful in getting the school bus to come to Hamlet. Pick up and drop off is at the water shed.

The old road is not the RM's responsibility.

Waterboard: Hamlet board and Water board will work together.

The Hamlet board is working on a new policy document to send to the RM for approval.

**Roads and road allowance:** Roads encroaching on residents' property, allowance parking, shed storage, and obstructions continue to be ongoing complaints regarding the roads and road allowance. The Chair received a quote from a company called 20/20 Geomatics cost of \$30,000.00. The RM was presented with the quote, the benefits of having the road/road allowance survey and a request to assist with payment. The RM has agreed to pay 30% of Hamlet's cost. The rest of the cost will come from money budgeted for Quonset roof.

The chair also got a quote if residents wanted their property surveyed. The cost for resident's lot is \$1250.00 plus tax to be billed to and directly paid by landowner. The board will send details regarding this shortly. Please be patient getting all the roads back to where they should be. Surveying designated for October 2024.

The board plans to discuss future road improvements with the RM once the survey is complete. Residents were reminded that repairs are expensive, and financially it could take years to address the current issues, and some issues may never be addressed.

The speed limit going up and down the hill will remain at 40 KM.

There was a suggestion to investigate the cost of Hamlet purchasing a skid steer or similar equipment.

Chair read a draft for Recreational Use Policy and Procedure for use and maintenance of Crown Resource land for approval from RM. The residents support the having a policy. The board will move forward and present the policy to the RM.
