# 5. New Business:

**Complaint: Received August 29,2025** 

i) The board received a complaint regarding the tree/shrub/removal/trimming notice taking place on North Haven Drive and Parkview Road. The board

addressed the complainant at the meeting. A response will be sent by the board.

# The response to the complainant will include the following:

- Any accidental private property damage caused by individuals working on behalf of the Hamlet of Parkview will be addressed through the RM of Marquis and its insurance.
- The RTM provides the Hamlet Board with the necessary permission to perform work using volunteers.
- The Hamlet Board does not have a policy regarding planting on road allowance. However, the RM of Marquis has a bylaw, established in 1963, that prohibits planting within 150 feet from the center of a road allowance. A copy of this bylaw nis attached for your reference.
- A professional contractor will be engaged to install an appropriately sized culvert for your driveway entrance. This work will be completed in accordance with all relevant acts, bylaws, and regulations.
- Please be aware that no permits were ever issued for the installation of these private lines, which means there are no official records of their precise locations. This lack of documentation can lead to complications, including accidental damage or the need for relocation during construction projects. As these lines were installed without official permission, they remain the sole responsibility of the line owners, not the Hamlet of Parkview board or the RM of Marquis. If a private line is accidentally damaged during construction, it will be repaired as a sign of good faith. However, if the needs to be relocated due to construction project, the cost of relocation will be the sole responsibility of the line owner. If ownership of a line cannot be immediately established, or if the identified owner chooses not to cover the relocation costs, the line interfering with the project will be removed and capped. To reiterate, all private lake pump water and electrical lines are the responsibility of the owner, not the Hamlet of Parkview Board or the RM of Marquis. Any work to repair an accidental break is performed as a courtesy and may be discontinued at any time.
